Summary

The course "Social Protection of the Population" provides for familiarization with the most relevant approaches of foreign and domestic authors on the financial provision of social protection of the

population, reveals the vision of the teacher, formed on the basis of his own research. During the course of the course, students will learn how to navigate the system of sources of social legislation of Ukraine and international legal regulation of social protection, justify priorities and calculate indicators of financial support for social protection of the population, calculate various types of social benefits for all segments of the population entitled to receive them, analyze social indicators, predict the consequences and trends of the development of the social security and social support system and find the right management.

Course objectives and goals

Acquisition of theoretical knowledge and practical skills in the field of management related to the financial provision of social protection of the population (including at the level of the state, enterprises and households).

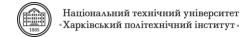

Features of the course, teaching and learning methods, and technologies

Lectures are conducted interactively using multimedia technologies. During practical classes, situations and real analytical indicators, social indicators, and financial reporting are used. All practical tasks are as close as possible to the real activity of financial and social institutions, and the formation of conclusions from the calculations carried out as part of the implementation of the tasks set in the practical classes should take into account the current state of the economy of the country and the region. Emphasis is placed on the use of information technologies in the field of social protection of the population.

Program of educational discipline

Topics of lectures

Topic 1. Social protection of the population: content and principles of functioning

The concept and meaning of social protection of the population. Subjects and objects of social protection. Characteristics of social protection functions. Evolution of systems of social protection of the population in the world. Forms of implementation of social protection of the population. Concepts, principles and structural features of systems of social protection of the population in different countries of the world. Formation of the social protection system in Ukraine.

Topic 2. Social policy of the state

Social policy as a necessary component of social development. The essence of social policy, its legal and financial support. Object, subject, methods and tasks of social policy. Main directions and priorities of social policy. Principles of social policy implementation. Subjects, mechanisms and tools of social policy. Man as a subject of social policy.

Topic 3. Management of the system of social protection of the population

State authorities, their role in the organization of social protection of the population. The Ministry of Social Policy in Ukraine: main tasks, rights, functions and areas of its activity. Local departments of social protection of the population, their purpose and tasks. Pension Fund of Ukraine. Accumulation fund. Social Insurance Fund of Ukraine. Fund of compulsory social insurance of Ukraine in case of unemployment. Non-state institutions and their role in the implementation of social protection of the population.

Topic 4. Compensation mechanisms, guarantees, benefits in the system of social protection of the population

State social guarantees and state social standards. The concept of subsistence minimum, the limits of poverty, the limits of poverty. Indexation of monetary incomes of the population. State guarantees to victims of Nazi persecution and political repression. Social guarantees to Heroes of Labor, Heroes of Ukraine. Social guarantees for citizens who suffered as a result of the Chernobyl disaster.

Topic 5. Budget provision of social protection of the population

Budgetary financing of expenditures on social protection of the population. State assistance for families with children. State assistance to low-income families. State aid to the disabled. Social protection of war and labor veterans. Assistance in solving the housing issue. State aid for youth.


Topic 6. Tax regulation of social protection of the population

Tax support for low-income and socially vulnerable segments of the population. Toolkit of tax regulation of effective population employment. Tax incentives for non-state social and pension insurance. The mechanism of payment of a single social contribution to the mandatory state social insurance. The mechanism for payment of the mandatory state pension insurance fee for certain types of economic transactions.

Topic 7. State trust funds in the system of social protection of the population

The place of social insurance in the system of social protection of the population. The need and economic essence of social insurance. Characteristics of the functions and principles of social insurance organization.

Topic 8. Social insurance for temporary disability



Formation and use of the social insurance fund. Material support and social services under temporary disability insurance. The procedure for calculating the average salary (income) for the calculation of payments under the mandatory state social insurance. Assistance for the period of temporary incapacity for work. Assistance during pregnancy and childbirth. Burial aid.

Topic 9. Social insurance against accidents at work and occupational diseases

The essence of social insurance against accidents at work and occupational diseases. Material support and social services in the event of an accident and occupational disease.

Topic 10. Social insurance in case of unemployment

Necessity and economic content of unemployment insurance. Organizational and financial principles of the activity of the social insurance fund in case of unemployment. Types of financial support and social services in case of unemployment. Calculation of the amount of insurance payments in case of unemployment.

Topic 11. Medical insurance

Medical Insurance. The essence, tasks and forms of medical insurance. Problems and prospects of introducing mandatory health insurance in Ukraine. Characteristics of the voluntary health insurance market in Ukraine.

Topic 12. Financial provision of pension protection

The essence of financial provision of pension protection of the population. Institutional foundations of building a system of financial support for pension protection of the population. Financial mechanism of pension provision. Mandatory state pension insurance. Insurance experience. Concept and types of pensions in the solidarity pension system. Special pension provision. Appointment and payment of pensions. Pension payments at the expense of the accumulative system of pension insurance.

Topic 13. Non-state financial provision of social protection of the population


The system of non-state pension insurance and its principles. Types and subjects of non-state pension provision. Asset management of non-state pension funds. Investment activity of non-state pension funds. Pension payments. Insurance companies in the system of non-state pension provision.

Topic 14. Global mechanisms of social protection of the population

Concepts, principles and structural features of systems of social protection of the population in different countries of the world. The role of the International Labor Organization and other international organizations in the protection of social human rights. Development of national systems of social protection of the population in the world. International social standards.
