To form and consolidate in future specialists modern economic thinking in the field of management of investment activities of enterprises, which requires the assimilation of basic theoretical provisions and the mastery of the necessary practical skills that should ensure its effectiveness.

#### Format of classes

Lectures, workshops, consultations, self-study. Final control in the form of exam.

#### **Competencies**

The ability to solve complex specialized tasks and practical problems in the field of conducting international banking business, which involves the use of various management decision-making methods in the implementation of cross-border banking operations through the formation of target directions for

the use of investment capital, to develop and implement financial services based on the use of modern information technologies.

#### **Learning outcomes**

PL 1. To have a variety of methods and tools for the development of a banking strategy, which includes the management of investment capital and the formation of complex financial instruments aimed at use in various target markets of the provision of banking services.

#### Student workload

The total volume of the course is 120 hours (4 ECTS credits): Lectures - 32 hours, workshops - 16 hours, self-study - 72 hours.

#### **Course prerequisites**

Successful completion of the course requires knowledge and practical skills in the following disciplines: scientific research fundamentals, financial management, insurance management, management information systems in the financial and accounting sphere, tax management, international financial reporting standards.
