General information

Summary

The course "Financial services industry" develops the knowledge and skills necessary for effective activity in the financial services market. In the course of training, students will learn how to identify the needs of consumers regarding certain types of financial services and the possibility of their satisfaction;

conduct a comparative analysis in the field of financial services, identifying advantages and disadvantages.

Course objectives and goals

Acquisition of theoretical knowledge and practical skills in the field of functioning of the financial services market. Formation of a comprehensive understanding of methods of financial services market regulation and mechanisms of activity of financial intermediaries and analysis of financial services.

Format of classes

Lectures, practical work, independent work, consultations. The final control is an exam.

Topic 1. Theoretical foundations of the functioning of the financial services industry
The essence and role of the financial services industry. The concept of "financial service" and its
difference from a financial transaction. Types of financial services. Subjects of the financial services
industry and their classification. Other financial participants of the financial services industry. The state
in the industry of financial services. Self-regulatory organizations.

Topic 2. The main tools of the financial services industry

Concepts of "financial asset" and "financial instrument". Types of financial instruments.

Topic 3. Concept and classification of financial intermediation

The theory of financial intermediation and its evolution. Deposit financial intermediaries in the industry of financial services. Non-deposit financial intermediaries in the industry of financial services. Insurance companies. Non-state pension funds, their types and management bodies. Joint investment institutions in



the industry of financial services. Financial companies providing leasing and factoring services. Methods of remuneration of financial intermediaries.

Topic 4. Segmental structure of the financial services industry

Concepts and criteria of financial services market segmentation. The main segments of the financial services market. The infrastructure of the financial services market. Concepts and components of the infrastructure of the financial services market. Functions of the financial services market infrastructure. Factors affecting the infrastructure of the financial services market.

Topic 5. Financial services on the money market

Organization and features of the functioning of the deposit market. Services of banks in the money market. Operations with money market instruments. State financial institutions on the money market. Topic 6. Financial services on the foreign exchange market

General characteristics of the foreign exchange market: concepts, functions, subjects, mechanism of functioning. Exchange rate and quotes. Currency transactions and their types. Provision of conversion operations services. Spot and forward operations. Currency arbitrage strategy. Carrying out transactions on the interbank foreign exchange market. Financial services for international settlements.

Cryptocurrencies: socio-economic essence and legal status. Modern regulation of financial services on the foreign exchange market.

Topic 7. Financial services on the loan market

Banking services on the credit market. Leasing and leasing operations of banks. Factoring operations mechanism. Other services of commercial banks in the financial market.

Topic 8. Financial services on the stock market

The concept of the stock market. Organization of trading on the stock market. Types of professional activity on the stock market. Stock exchanges and their place among financial services market exchanges. Methodology of evaluation and analysis of securities.

Topic 9. Financial services on the insurance market

Structure, participants and tools of the insurance market. Practice of insurance services in the USA. Insurance companies and services in Ukraine. Indirect insurance intermediaries and their services. Instruments of state regulation of the insurance services market in Ukraine.

Topic 10. Services of non-state pension funds

Pension contract and pension scheme. The procedure for concluding and essential conditions of the pension contract. Effect of the pension contract. Concept and types of pension schemes. Pension assets of non-state pension funds. Asset management of non-state pension funds. Investment activity of non-state pension funds. Pension payments. Types of pension payments, conditions and procedure for their payment. Life pension. Life pension insurance contract. Pension for a certain period. Agreement on the payment of a pension for a certain period. One-time pension payments.

Topic 11. Lombard services

Origin and development of the market of pawnshop services. The essence and importance of the market of pawnshop services. Services of pawn lending and storage of valuables. State regulation of the market of pawnshop services.

Topic 12. Financial services of international financial markets

The role of the global financial system - its functions and components. Eurocredit and eurocurrency markets and their services. International capital market: concepts, main tools. FOREX (FX) foreign exchange market. International information, payment and settlement and dealing systems for the provision of financial services.

Topic 13. Foreign trade financing services

Services for international payments and settlements in foreign trade. Ways and tools of financing foreign trade

Topic 14. Latest electronic financial services

Internet banking. Internet trading. Internet insurance and computer engineering.

Topic 15. Information provision of financial services

The main sources of information provision of financial services markets. Fundamental analysis of financial markets and use of the obtained information for the provision of services. Technical analysis of financial markets and use of the obtained information for the provision of services.

Topic 16. Risks in the market of financial services

Uncertainty factors in the market of financial services. Types of risks in the market of financial services. Credit risk management. Methods of currency risk insurance. Hedging using options, forwards, futures. Interest rate risk management.
