Requirements for abstracts: The volume of abstracts is up to 3 pages in MS Word, Times New Roman font, 14 pt, single line spacing, paragraph – 1.25 cm; margins: top, left, right and bottom – 2 cm. Figures should be placed in the text, with the text border at the top and bottom, in the center. Under the figure, indicate the numbering (Fig. 1) and title. When using tables, indicate the numbering (Table 1) and title. The font size in the tables is 12, the interval is 1.

Structure of the abstracts:

- Title of the abstract (bold, capital letters, size: 12, centered in the text).
- Full name of the author (bold, size: 12, on the right edge, no more than 3 authors are allowed) and information (academic degree, academic title (if any); position, educational institution, place of work in case of graduation; city in which it is located, state; ORCID (if any)).
- Main text.
- List of references (in alphabetical order).

The list should be drawn up in accordance with the National Standard of Ukraine DSTU 8302:2015. References to the sources used in the text should be made in square brackets. Please note that the list of references should be based on domestic and international scientific research of the last 5 years (excluding sources from the aggressor country and Belarus).
