# **General information**

#### **Summary**

The course is focused on mastering the basic laws of the structure and principles of development of international economic integration and international organizations, their role in the system of international economic relations, the ability to analyze benefits and possible losses from the country's participation in certain organizations.

### **Course objectives and goals**

Acquisition of theoretical knowledge and practical skills and study of basic conditions, functions and principles of international economic integration and mechanisms of functioning of international organizations. Formation of students' skills and conscious involvement in deepening Ukraine's integration into the world community

#### Format of classes

Lectures, practices, consultation. Final control in the form of an exam
