#### **General information**

#### Summary

The course is aimed at obtaining theoretical and methodological knowledge in the field of finance, mastering the laws of their development at the macro and micro levels, as a theoretical basis for financial policy and the development of international financial systems. Gives an idea of the mechanisms and organizational structures that ensure the functioning of the country's financial system, involves mastering the skills of researching the theoretical foundations and practical implementation of issues of the organization of finances at the micro level, as the basic sphere of the financial system of Ukraine.

#### **Course objectives and goals**

To form a general idea and to give a correct understanding of the laws in the field of financial relations of the state, subjects of entrepreneurial activity and the population and to reveal the ways of using these laws in the practice of financial work; to show the possible directions of the influence of finance on social progress and the role of finance in the economic restructuring of society on the way to the development of market relations; determine a set of measures that ensure the use of finance as one of the levers of the economic policy of the state.

#### Format of classes

Workshops, consultations, self-study. Final control in the form of a exam.
