## **General information**

### **Summary**

The educational discipline is aimed at mastering the organizational and legal principles and rules of customs arrangement. The main focus is on customs taxation and customs valuation goods that are moved across the state borders of the country during the execution of international contracts, and having the tools and procedures to move goods and citizens through the state border of Ukraine.

#### Course objectives and goals

To form systematic professional knowledge and practical skills in matters of export coordination and import operations of an international firm, to be able to evaluate their effectiveness, taking into account peculiarities of customs regulation; master the methods and tools of tariff and non-tariff regulation of international business; be able to estimate the customs value of goods and calculate customs payments; to acquire practical skills of filling out a customs declaration on goods moving across the state border of Ilkraine.

#### Format of classes

Lectures, practical classes, independent work, consultations. The final control is an exam.

- Topic 4. Tariff regulation of foreign trade in Ukraine.
- Topic 5. The concept and definition of the country of origin of the goods. Non-tariff regulation of external trade in Ukraine
- Topic 6. Incoterms are international commercial terms
- Topic 7. Customs value of goods
- Topic 8. Customs payments. Customs declaration when moving goods across the customs border of Ukraine

- Topic 1. Structure and organization of activities of the customs service of Ukraine
- Topic 2. Determination of the UKKTZED product code
- Topic 3. Determination of the country of origin of the goods

- Topic 10. Calculation of the customs value of goods when imported into Ukraine on the basis of value addition
- Topic 11. Calculation of the customs value of goods when imported into Ukraine on the basis of subtraction cost
- Topic 12. Calculation of the customs value of goods when imported into Ukraine by the reserve method
- Topic 13 Calculation of the customs value of goods when exporting from Ukraine
- Topic 14. Calculation of customs payments when importing goods to Ukraine
- Topic 15. Calculation of customs payments when exporting goods from Ukraine to EU countries
- Topic 16. Filling out the customs declaration

### Topics of the laboratory classes

#### **Self-study**

Stages of customs control and customs clearance of the import of goods to Ukraine in accordance with individual terms of the foreign trade agreement. Successful completion and defense of coursework work involves the completion of 7 meaningful parts:

- 1. Organization of activities of the customs system of Ukraine.
- 2. Determining the product code in accordance with the UKT ZED.
- 3. Determination of measures of tariff and non-tariff regulation of foreign exchange.
- 4. Determination of the contract value of the goods.
- 5. Determination of the customs value of the goods.
- 6. Calculation of customs payments.
- 7. Issuance of a customs declaration.



Students are offered independent study of the topic "Customs regimes", which includes consideration of such questions:

- 1. Customs regimes of goods moving across the state border of Ukraine. General characteristics of customs regimes.
- 2. Customs regime of import.
- 3. Customs regime of reimport.
- 4. Customs regime of export.
- 5. Customs regime of re-export.
- 6. Customs regime of transit.
- 7. Customs regime of temporary import/export.
- 8. Customs regime of customs warehouse.
- 9. Customs regime of the free customs zone.
- 10. Customs regime of duty-free trade.
- 11. Customs regime of processing in the customs territory.
- 12. Customs regime processing outside the customs territory.
- 13. Customs regime of destruction or destruction.
- 14. Customs regime of refusal in favor of the state.
