General information

Summary

The discipline "Educational Management" allows students to master modern approaches to the management of educational institutions, features of management in higher education, the possibility of effective interpersonal interaction, the ability to take into account diversity, individual characteristics of students in the planning and implementation of the educational process in an educational institution, the ability to carry out expertise and provide advice on educational policy and innovation in education.

Course objectives and goals

The aim of the discipline is: - mastering by master students of modern managerial thinking and a system of special knowledge in the field of educational management; formation of understanding of the conceptual foundations of system management of educational institutions; the ability to apply the functions and principles of management in education, making adequate management decisions.

Format of classes

Lectures, practical classes, independent work. Final control - credit.

Student workload

The total volume of the discipline is 180 hours (6ECTS credits): lectures - 32 hours, practical classes - 32 hours, independent work - 116 hours.

Course prerequisites

To successfully complete the course, you need to know: psychology of decision-making in education/pedagogy, monitoring the quality of education in higher education, pedagogy and psychology of higher education, etc.

Features of the discipline, teaching methods and technologies

Lectures are conducted interactively using multimedia technologies. Lectures include: story, explanation, demonstration, discussion. In practical classes, students perform group and individual tasks.

According to the sources of knowledge, the following teaching methods are used: verbal - conversation, discussion, lecture, work with the book; visual - illustration with practical examples, presentation; gaming - role-playing, business games; documentary - work with documents, analysis, preparation of documents; interactive - selection and discussion of video materials, cases, speech with presentation; self-study - processing of lecture material and professional literature; research - theoretical analysis of scientific sources, empirical research.

By the nature of the logic of knowledge, the following methods are used: analytical, synthetic, analytical-synthetic, inductive, deductive.

By the level of independent mental activity, methods are used: problematic, partially exploratory, research.

Learning materials available to students in Google Disk and One Drive cloud environments.



Topic 4. Management in higher education.

Management in modern higher education institutions. Features of management in the university. Functions and principles of higher education management. System of key performance indicators (KPI) in higher education institutions.

Topic 5. Leader in an educational institution.

The concept of leadership and management. Adaptive management in modern educational institutions. Basic skills and roles of leaders. Leader in higher education: features and differences. Characteristics of the main leadership styles.

Topic 6. Management of personnel of educational institution.

Basic scientific approaches in the theory of personnel management of educational institution. The need and main stages of introducing changes in the work with scientific and pedagogical staff. Selection and recruitment of staff of an educational institution. Performance analysis and staff evaluation. Staff development. Motivation of staff.

Topic 7. Organizational culture of a modern educational institution.

Self-development of scientific and pedagogical staff of higher education institutions in the context of organizational culture. Organizational culture as a basis for the development of an educational institution. Professionalism and organizational culture. The experience of the head of the institution in the implementation of organizational culture.

Topic 8: Marketing in education and public relations.

Content and features of marketing in education. Marketing in modern higher education institutions. Marketing analysis and control. The need and main stages of introducing changes in the work with scientific and pedagogical staff. Public relations in education

Interrelation of management functions in educational institutions. Strategic planning in higher education institutions.


Topic 5. Personnel management of an educational institution.

Students are also recommended additional materials (videos, articles, textbooks) for independent study and analysis, preparation for lectures and practical classes.




