General information

Summary

Since economic activity is inextricably linked with the cultural, social and political dimensions of social life, philosophical knowledge reveals the social, technological, scientific foundations of the economy, historical and cultural aspects of human economic activity, and also shapes the worldview of students, promotes the development of their spiritual world, culture of thinking, creative skills in learning about the surrounding world and personal activity

Course objectives and goals

Acquaintance of students with the history of formation and modern trends of the philosophy of economic activity, formation of a system of knowledge about universal principles and historical and cultural factors of economic development; formation of an idea about the meaning, purpose, principles of economic activity, the specifics of the economic life of a person; highlighting the dynamics of development and the main achievements of philosophical and economic thought

Format of classes

. Lectures, practical classes, independent work, consultations. The final control is a credit test.

Features of the course, teaching and learning methods, and technologies

When teaching lecture material, an explanatory and illustrative method is used (with the help of educational and methodological literature, a lecture, a teacher's story, electronic learning tools, etc.), which involves students' perception, awareness and understanding of facts, theories, concepts, philosophical and sociological paradigms. The problem statement method is used to compare various approaches and concepts, scientific research through the formulation of a research problem and analysis of scientific texts and primary sources. For seminar classes, the reproductive method (reproduction of the material learned during lectures) and the partial research method (students learn to solve cognitive tasks set by the teacher, present the results of their own scientific research in the form of projects) are used.
