General information

Summary

"State regulation of the economy" is an optional educational discipline for higher education students studying for the master's degree in the specialty 054 "Sociology". The educational discipline provides for the study of the scientific foundations of the management of the socio-economic development of the country, the goals, forms, methods and tools of state influence on the market economy, as well as the peculiarities of the regulation of entrepreneurship and certain spheres of economic, scientific, technical and innovative activity, coverage of the management of structural restructuring, regulation of development regions and use of

natural resources, nature protection and natural environment. The problems of state regulation of the domestic economy are considered through the prism of world experience of influence on economic and social development, global trends and national characteristics, taking into account the realities of economic and socio-political life in Ukraine. The discipline program is aimed at studying the theoretical aspects of the formation, functioning and development of the system of state regulation of the economy of Ukraine

Course objectives and goals

The purpose of studying the discipline "State regulation of the economy" is the formation of students of higher education with modern thinking and special knowledge regarding the theoretical and methodological foundations of state regulation of the economy, understanding of development trends and modern modifications of models of state regulation of the economy, the essence, methods and mechanisms of state regulation of the economy of Ukraine in the context systemic economic transformation and globalization, as well as the acquisition of skills and the formation of competencies necessary to perform the functions and exercise the powers of state authorities and local self-government, the training of erudite and qualified specialists who must correctly understand and justify the state economic policy, be able to solve general economic issues, predict the consequences of one or another decision, find ways to solve modern economic problems.

Format of classes

Lectures, laboratory classes, consultations, self-study. Final control in the form of an credit.

Features of the course, teaching and learning methods, and technologies

Lectures are conducted interactively using multimedia technologies. Practical classes use: game design; work with legislative acts and other normative legal documents; speeches-presentations; development of lecture material and professional literature.

Principles of state regulation of the economy. Historical aspect of the emergence of state macroeconomic regulation. Classification of the goals of state regulation of the economy. Objects and subjects of state regulation of the economy. Classification of objects of state regulation of the economy. The

main tasks of subjects of state regulation of the economy. The essence of the concepts of efficiency and effectiveness in the system of state regulation of the economy. Peculiarities of determining economic and social efficiency in the SRE system. SRE efficiency indicators. Peculiarities of state regulation of the economy in wartime conditions.

Topic 2. Strategy of socio-economic development of the country

Social needs and interests. Justification of goals. Hierarchy of goals. State priorities. Tree of goals. Strategic, tactical, operational goals. Post-industrial society. Concept of socio-economic policy. Socially oriented market economy. Strategy of sustainable development strategy and economic and social policy of Ukraine. The essence of the concepts: "forecast", "hypothesis", "plan (program)". Functions of socio-economic forecasting. Principles of socio-economic forecasting: scientific validity, adequacy, alternativeness, systematicity, purposefulness. Classification of socio-economic forecasts. Typology of forecasting methods. Intuitive and formalized methods of forecasting Directive and indicative planning The essence of reforming macroeconomic planning.

Topic 3. Structural and investment policy.

The concept of regular management and business engineering. The technology of development and implementation of the organization's strategy. Technology of organization management structure formation. Restructuring of enterprise management. The concept of the structure of the economy. The role of structural changes in economic development. Characteristics of the structure of the economy of Ukraine. Types of economy structure. Reproducible proportions. Industry structure. Regional structure. The essence of the structural effect. Coefficient of absolute structural shifts. Coefficient of relative structural shifts. The impact of structural changes on the dynamics of the production function. The concept of priorities of socio-economic development. Criteria for determining state priorities. Active structural policy. The main factors of structural changes. The impact of structural changes on the dynamics of macroeconomic indicators.

Topic 4. The main forms of state influence on the socio-economic development of the country.

Financial and budgetary regulation. State finance. Consolidated balance of financial resources. National budget. State non-budgetary funds. Revenues and expenditures of the state budget. Structure of budget expenditures. Budget classification. Grants, subsidies, subventions. Deficit, surplus, sequestration of the state budget. State debt. Stages of the budget process. Strategy and tactics of the financial and budgetary policy of Ukraine. Tax regulation. The tax system. The taxation system. System of tax authorities. Functions, types and forms of taxation. Principles of construction of the tax system. National taxes and fees in Ukraine. Tax burden. Tax task

Topic 5. Entrepreneurship as an object of state regulation.

Entrepreneurship as an object of state regulation. Entrepreneurship: economic meaning and role in the economy of Ukraine. Types of entrepreneurial activity, their characteristics. Classification of forms of entrepreneurship. Innovative enterprise. Organizational and legal forms of entrepreneurship. The role of the state in the formation of the business environment in Ukraine. Problems of entrepreneurship development. The essence of the state policy of promoting entrepreneurship. State regulation of privatization. Antimonopoly policy of the state. Institute of Bankruptcy and Rehabilitation of Enterprises. Problems of legalizing the shadow economy in Ukraine.

Topic 6. State regulation of foreign economic activity.

State regulation of foreign economic activity. Principles of foreign economic policy. The essence of the concept of "foreign economic policy". Tasks and principles of foreign economic policy. Legal framework for regulation of foreign economic activity. Legal regimes for foreign entities and economic activity on the territory of Ukraine. Types of foreign economic activity. System of bodies of state regulation of foreign economic activity. Methods of regulation of foreign economic activity. Strategy and tactics of foreign economic policy of Ukraine. Regulation of trade activity.

Topic 7. State regulation of socio-economic development of regions.

Regional economic policy. The essence of concepts: region, regional economic policy, regional structure of the economy. The region as a socio-economic system. Objects and subjects of regional policy. Principles and priorities of state regional policy. Regional development strategy. Components of regional economic policy. Strategy and tactics of regional policy of Ukraine. Legislative basis of the regional policy mechanism. Constituent elements of the regional policy mechanism. Functions of central state bodies and local state administrations in relation to regional economic policy

Topic 8. State regulation of labor, the standard of living of the population and the development of social and environmental policy.

State regulation of the labor market: legal, organizational and economic levers. Institutional and public regulation of the labor market. Subjects of the labor market: employers, employees, trade unions, the state.

The role of trade unions in labor relations. State and contractual regulation of wages. Normative and tax regulation of wages. The system of tariff agreements, its importance in the regulation of labor remuneration. Dependence of remuneration on its productivity, quality of manufactured products, qualification of the worker. The minimum wage. Wage indexation.

Peculiarities of state regulation of the economy in wartime conditions.

Definition of the main functions of socio-economic forecasting and principles of socio-economic forecasting: scientific validity, adequacy, alternativeness, systematicity, purposefulness. Consideration and familiarization with the classification of socio-economic forecasts. Compilation of a typology of forecasting methods. Definition of intuitive and formalized forecasting methods. Task and essence of reforming macroeconomic planning.

Topic 3. Structural and investment policy.

Definition of the concept of the structure of the economy. Determination of the role of structural changes in economic development. Analysis of characteristics of the structure of the economy of Ukraine. Acquaintance with the types of structure of the economy, reproductive proportions. Tasks and methodology of the branch structure. Definition of regional structure. Concept and essence of structural effect. Determination of the coefficient of absolute structural shifts, the coefficient of relative structural shifts. The role and place of influence of structural shifts on the dynamics of the production function. Development of the concept of priorities of socio-economic development. Analysis of criteria for determining state priorities. Acquaintance with active structural policy. Implementation of the main factors of structural changes. The role and place of influence on structural changes and dynamics of macroeconomic indicators.

Tasks and planning methodology of an innovative enterprise. Determination of

organizational and legal forms of entrepreneurship. Determination of the role of the state in the formation of the business environment in Ukraine. Consideration of the problem of entrepreneurship development. Determination of the essence of the state policy of promoting entrepreneurship. Definition of state regulation of privatization. Implementation of antimonopoly policy of the state. Consideration of the institution of bankruptcy and rehabilitation of enterprises. Solving the problem of legalization of the shadow economy in Ukraine

Topic 6. State regulation of foreign economic activity.

Acquaintance with state regulation of foreign economic activity. Determination of the principles of foreign economic policy. The concept and essence of "foreign economic policy". Implementation of tasks and principles of foreign economic policy. Determination of the legal framework for the regulation of foreign economic activity. Implementation and approval of legal regimes for foreign entities and economic activities on the territory of Ukraine. Definition of types of foreign economic activity. Development of the system of state regulatory bodies of foreign economic activity. Creation of methods of regulation of foreign economic activity. Development of strategy and tactics of Ukraine's foreign economic policy. Regulation and execution of trade activities.

Topic 7. State regulation of socio-economic development of regions.

Implementation of regional economic policy. Defining the essence of concepts: region, regional economic policy, regional structure of the economy. Concept - Region as a socio-economic system. Definition of objects and subjects of regional policy. Determination of the main principles and priorities of the state regional policy. Development of regional development strategy. Determination of components of regional economic policy. Compilation, consideration and approval of the strategy and tactics of the regional policy of Ukraine. Acquaintance with the legislative basis of the regional policy mechanism. Approval of constituent elements of the regional policy mechanism. Analysis of the functions of central state bodies and local state administrations in relation to regional economic policy.

Topic 8. State regulation of labor, the standard of living of the population and the development of social and environmental policy.

Tasks and methodology of state regulation of the labor market: legal, organizational and economic levers. Acquaintance with institutional and public regulation of the labor market. Definition of labor market subjects: employers, employees, trade unions, the state. The role and place of trade unions in labor relations. Execution of state and contractual regulation of labor remuneration. Determination of regulatory and tax regulation of wages. Implementation of the system of tariff agreements, determination of its importance in the regulation of labor remuneration. Determination of the dependence of wages on productivity, the quality of manufactured products, and the qualifications of the worker. Consideration, approval and implementation of the minimum wage. Approval and implementation of wage indexation

Norms of academic integrity and course policy


