Summary

The discipline covers the development of money from ancient times to the present. During its study students will get acquainted with the most well-known currency systems of the world and will be able to critically assess their role in the socio-economic development of the world. The means to achieve this will be an essay on a proposed or self-selected topic in the form of an abstract.

Course Objectives and Goals

Format of Classes

Lectures – 32 h., Seminars – 32 h., self-study – 56 h. Final control in the form of a credit test.
